Liability Release for the 2010 FLFA season

(A) By each team representative signing for this liability release, all team members understand and will abide by the rules set for any and all FLFA-run tournaments and are submitting an entry fee. All team members hereby waive and release the Florida Flatsfishing Association, LLC, the hosts, sponsors, and agents, (hereby referred to as "FLFA, ET AL") from any and all claims of injury and/or material and bodily damage in connection with the tournament.

(B) Covenant not to sue and waiver of subrogation: All team members further agree that we will never sue FLFA, ET AL, for damages on account of any injury we suffer or cause whether known now or which may develop from events or incidents that are directly or indirectly related to the tournament now, or in the future. All team members expressly agree to indemnify and hold harmless FLFA, ET AL from any liability whatsoever. All team members understand that in waiving our rights to sue FLFA, ET AL, we also are waiving the rights of recovery from FLFA, ET AL, of my insurance carrier for any claims that may pay in our behalf. Any and all litigations will be held in the Nineteenth Judicial Circuit state court of jurisdiction of Indian River County, Florida.

(C) he owner/operator of the team vessel further states that they maintain liability insurance on the vessel we will use in the FLFA tournament series and are in possession of said insurance, including but not limited to a certificate of insurance, and coverage limits.

(D) Any and all team members agree to submit to a polygraph test at any time, if requested by the tournament officials, and that said polygraph examiners decision will be accepted by us without further appeal. Failure of such polygraph will automatically disqualify us from the tournament series.

(E) All team members hereby release and agree that FLFA, ET AL, and their agents may photograph and or videotape us, in connection with this tournament and may use said photographs or videotape, and our name in any commercial use without our written consent during the 2010 FLFA tournament series.

(F) Each individual angler of a team is responsible for the reporting of winnings in excess of \$600.00 each event per person to the Internal Revenue Service.
