## Liability Release for the 2009 FLFA season

(A) In signing this liability release, we understand and will abide by the rules set for this tournament and are submitting an entry fee. We hereby waive and release the Florida Flatsfishing Association, the hosts, sponsors, and agents, (hereby referred to as “FLFA, ET AL”), from any and all claims of injury and/or material and bodily damage in connection with the tournaments during the 2009 season.

(B) Covenant not to sue and waiver of subrogation: We further agree that we will never sue FLFA, ET AL, for damages on account of any injury we suffer or cause whether known now or which may develop from events or incidents that are directly or indirectly related to the tournament now, or in the future. We expressly agree to indemnify and hold harmless FLFA, ET AL from any liability whatsoever. We understand that in waiving our rights to sue FLFA, ET AL, we also are waiving the rights of recovery from FLFA, ET AL, of my insurance carrier for any claims that may pay in our behalf. Any and all litigations will be held in the Nineteenth Judicial Circuit state court of jurisdiction of Indian River County, Florida.

(C) We further state that we maintain liability insurance on the boat we will use in this tournament and are in possession of said insurance, including but not limited to a certificate of insurance, and coverage limits.

(D) We agree to submit to a polygraph test, if requested by the tournament officials, and that said polygraph examiners decision will be accepted by us without further appeal. Failure of such polygraph will automatically disqualify us from the tournament.

(E) We hereby release and agree that FLFA, ET AL, and their agents may photograph and or videotape us, in connection with this tournament and may use said photographs or videotape, and our name in any commercial use without our written consent. I also agree that any and/or all FLFA sponsors may contact me without reservation.
